Public rate hearing. Okay. I'm going to announce that the public rate hearing is open to the public, and I'm going to turn it over to Mike, from Bowman & Bowman, our auditor, to go through and discuss the sewer charges and the connection fees. Mike?

MR. CRAGIN: Good evening. We're going to be talking about the two rates. The user rate will be increasing from \$636 to \$648, a dollar a month increase, and the base fee will go from \$165 to \$168. These increases represent about a 1.9 percent increase in the rate. The rate increase is necessary to support the anticipated debt service the authority will be issuing in approximately May of 2019 of \$4.1 million. It will also help to support contractual increases and other increases for authority expenditures.

The connection fee will be going down from \$4,039 down to \$3,946. The reason for the change is the total equivalent dwelling units increased by approximately 385 from last year; most of them being commercial, 190 was an increase in commercial. It decreased the average cost per EDU down to 3946.

Mr. LaFerla – In the back of my report is a quote for the new pickup truck; we put the money in the budget for it. We would like to get it.

Mr. Kendzulak, Jr. – Ms. Nicaretta, he's looking for a paragraph in writing?

Mr. Hazard – They've acted on it and approved it, but there's a ten percent, \$5,000.00 that has to come from us. The County is putting out a bid for \$50,000.00, so it's a grant, to do an economic study on this facility working with Master Plans, not just for Raritan Township but also for Flemington Borough, and the Township supports it.

Mr. Kendzulak, Jr. – When we had our meeting, they did mention the \$5,000.00, but they said our engineers' services as far as developing the scope of work would be applied toward that. That was my understanding. Anything in house, meaning our engineering work would be applied to that five percent.

Mr. Madden – For what it's worth, Mr. Bogen told me, and we've been tracking it, the time spent on the Wastewater Management Plan (WMP), we can get reimbursed.

Mr. Kendzulak, Jr. – I think we've exceeded the 5,000.00 already, so we may have met our obligation with regards to that. This is something that is moving the Authority forward. Without this WMP, we're not going anywhere.

Mr. Madden – We have a good handle on what's going on in Raritan Township, it's Flemington Borough that's our issue. The wording I gave them to go in this was "to do a more in-depth study of Flemington" because they're an urban location, for the WMP, it's all generated by population.

Mr. Hazard – There's a lot of work here that needs to be done.

Mr. Kendzulak, Jr. – This paragraph here, who is going to tailor this thing to basically say that Raritan Township MUA will pay in kind services or whatever. In the end we'll be spending \$5,000.00.

Mr. Madden – I think whatever you spend, he's going to be able to pay you back even though it's going to be more than \$5,000.00.

b) Christopher Bolka, Env. Spec. 3 of NJDEP to Tony Saracini, VP of Johanna Foods, Inc., regarding Compliance Evaluation and Assistance Inspection

Mr. Kendzulak, Jr. – I guess this is tied to some exceedances and Johanna is going to get penalized by the DEP.

Mr. Tully – This is in conjunction with the overages we've already billed them for?

Mr. Kendzulak, Jr. - That's my understanding.

c) Chrissy Gerstnicker of NJDEP to RTMUA regarding Responsible Licensed Operator for RTMUA

Mr. Kendzulak, Jr. – Ms. Nicaretta sent this form back with Mr. Frank's name. You sent it by fax too but did they receive the hard copy?

Ms. Nicaretta – Yes, I got confirmation from UPS.
