Mrs. Wohlleb – I have nothing to add unless there are questions.

Mr. Kendzulak, Jr. - The high school; maybe Mr. Watts can talk about it What is going on with the high school? Are we still waiting to hear back too. from them?

Mr. Watts - We got an agreement, I met with Mrs. Wohlleb and Mr. LaFerla, and I've been slow getting it out but I have a letter to go back to their attorney.

Mr. Kendzulak, Jr. – Are we still in line time wise; to get this thing out so we can build it?

Mrs. Wohlleb – We're getting to the point where it could be an issue. We are ready. Part of what they asked for in their Agreement is they asked for contractual language in the construction contract which is something that Mr. Watts is part of in resolving that. There were somethings they were going to do

to restore grandstands etc. and they have to respond to that and to agree that the final sewer alignment that we have at this point is okay with them.

Mr. Kendzulak, Jr. – Should we be telling them that they need to buy this or it may not happen this winter; it needs a TWA, correct?

Mr. Tully - Yes.

Mr. Kendzulak, Jr. – How long could that take?

Mrs. Wohlleb – It could take as much as one hundred twenty days. You can do an expedited one and you can get it much quicker; maybe in a matter of weeks.

Mr. Kendzulak, Jr. – What does that mean?

Mrs. Wohlleb - Expedited means if you're doing a very basic TWA like for a sewer extension, you can move more quickly through the review.

Mr. Kendzulak, Jr. – What I don't want to do is this thing goes down and we find out, that because of the TWA, we don't end up doing it and we lose a whole year here.

Mr. Watts – They did send us a skeleton Agreement, no numbers in it on how it is to be allocated and they're insisting on us giving up our blanket easement on the entire property; my recommendation to you is you don't do that. If we have it, we should keep it and we'll just extinguish it under the football field but that's it.

Mrs. Wohlleb – We're the ones submitting the TWA.

Dr. Buza – You said we're extinguishing the easement under the football field? Why?

Mrs. Wohlleb – Where the pipe is being abandoned, it isn't needed there.

Mr. Tully – They were talking about starting it in December or January.

Dr. Buza – Is it still the Wilentz firm?

Mr. Watts – No, they got Parker, McCabe, a bigger national firm. It's a waste of money. I said to the woman "you know there are lots of local attorneys you can use" and she said "yes, I'm thinking about it" and then I get a phone call from a guy down in South Jersey from a national law firm.

6. RTMUA Reports:

a) ADMINISTRATIVE / OPERATIONS REPORT

1. Chief Operator / Director's Report

Mr. LaFerla – The only thing I have to add is Chuck Schneider, the Maintenance Supervisor put in his paperwork to retire; he retires, April 1, 2017.

Mr. Tully – Are you going to have someone shadow him around six months before he retires?

Mr. LaFerla – Yes.

Chair Kinsella – I have a question, in your report, number fourteen; it says "There continues to be SCADA server failures due to the age of the server and hardware."

Mr. LaFerla – Yes, they're about six years old, I got prices, it'll be about \$37,000.00 or around there; three servers and two work stations that have to be replaced.

Mr. Tully – Six years is a long time. It's like dog years with the technology. Ours is going on five in our office and we're replacing them this year. New components aren't compatible anymore, if the SCADA system is going to advance, you might run into hardware issues, where the new stuff isn't compatible with the old stuff and you run into problems.

Chair Kinsella – So the new stuff is to be proactive for the future?

Mr. LaFerla – Yes.

Chair Kinsella – It's sad that the system is getting old and it isn't even completed yet.

7. <u>Discussion:</u>

a) Peggy Gallos of AEA

b) 2nd Quarter 2016 Capacity Evaluation

Mrs. Wohlleb – Another dry quarter, similar to the previous reports, we first take a look at what we report to NJDEP, on the third page of the report, the WQM-007 form and basically just looking at our committed flows from our open Treatment Works Approval Permits, we flowed at 2.41 MGD, our anticipated flow coming from our TWA's is about 133,000 gpd, so our total committed flow is 2.54 MGD and of course out of our treatment plant capacity of 3.8 MGD, according to NJDEP, we have 1.26 MGD of remaining capacity. When we take a look at the next layer, considering all of our allocations, all of our Agreements, service Agreements that are out there; and at this point, this report does not reflect the expiration of the Permit Extension Act, because we are looking back at the last quarter. June 30th being the cut off for the quarter and it may look different for the next quarter, the 3rd Quarter but based on those allocations and our Agreements with Flemington and Readington, we have a total allocation of a little more than 1 MGD and again the Plant is flowing at a very dry low of 2.41 MGD so our total committed flow with all of our contracts is about 3.4 MGD compared to our 3.8 MGD, we then have a remaining capacity of 370,000 gpd.

Mr. Kendzulak, Jr. – Now if you back out all the ones that have expired, what does that number become?

Mr. Watts – Another 80,000 gpd or so?

Mrs. Wohlleb – Maybe something like that I don't have the current information.

Mr. LaFerla – It was about 30,000 gpd.

Mr. Kinsella - 33,600 gpd; and the 66 EDUs that came back from the Trade Center.

Mr. Kendzulak, Jr. – That will all be reflected in the next quarterly report? Mrs. Wohlleb – Yes.

c) Draft of Budget

Mr. LaFerla – Mrs. Struening and I have been working on the budget; this is a draft, basically the only things that are missing are the chemical bids, the janitorial and mowing proposals. The bid opening is August 2nd and the proposals are due by August 5th so by the first week in August we'll have numbers to put in. If you have any questions, I'll answer them.

Mr. Kendzulak, Jr. – You need more data here, some more numbers. Just looking at this, we had a budget last year of \$5,419,000.00 and this year so far we have \$5,432,000.00 now so not too much of a change.
