c) Commissioner's Comments:

Mr. Del Vecchio – I see this notice, which I knew was coming, on phosphorus. This came from the State letting us know the hearing is July 16, 2014. It will probably get published and everything by the third quarter. When is our permit for this plant up?

Mrs. Wohlleb – We are waiting for comments back from DEP; I think we submitted about a year ago on August 13th.

Mr. Coe- They have it but they haven't reissued the permit.

Mrs. Wohlleb – We submitted the renewal application and they have not commented on it.

Mr. Kendzulak, Jr. – If they impose phosphorus limits on it, we have three years?

Mr. Coe – That's what I've heard. Originally I was saying five; they were giving you a permit cycle. DEP felt that since everyone has known this is coming for ten years, they may be inclined to give less than the five. Obviously we will argue for more if they come down with three because that's unreasonable to get financing, engineering and everything else into place.

Mr. Kendzulak, Jr. – So it's premature to address this with the budget at this time?

Mr. Coe – Yes, first you need to see what the number is going to be then we do a relatively quick study on what the alternative treatment methods are and see what's the most economical way to address it.

7. Discussion:

a) Block 16.01 Lots 37.01 & 54 Capacity Request for Affordable Housing

Mr. Miller – This has been around and it's by the Hunterdon Central High School on Junction Road. They are a big company and I think all they do is COAH type developments. What he is asking for is can he get capacity so what he is really asking for is a Point System.

Mr. Del Vecchio – What is the property zoned for?

Mr. Kinsella – I-2 zone?

Mr. Kendzulak, Jr. – The question is, is this a Board of Adjustment or does the zoning provide for this?

Mr. Miller – I'll talk to Ms. Sunyak about this. It's obviously not something that needs immediate attention but it needs attention.

Mr. Del Vecchio – They are asking us to respond to them and when we were doing the Yale property and the Point System, that was all still zoned commercial and industrial and they wanted a little bit for residential on it, we didn't give that to them because it wasn't zoned for that. I think we need to do the same thing here, we need to look at what is the current zoning on that block and lot and then if it is still commercial or industrial we need to go back to them and say that the piece of property that they are looking at is not zoned for that.

Mr. Watts – Back in the day when we made direct allocations, we reached an agreement with the Township that if a property was not zoned for the new use or needed a variance we wouldn't make a preliminary allocation and they would have to get their approvals first. So regardless, they should probably be told that we don't have capacity unless we go through a Point System allocation and it would need to be in accordance to zoning.

Dr. Dougherty – I recommend Counsel right the letter.

Mr. Del Vecchio – Anything else from the Commissioner's?
