Mr. Madden – The second clarifier was put back on line, so we have two running, two to go and they're taking a break until the Spring. Warmer temperatures are needed for the coatings. Same for the Flemington Wet Weather Facility (FWWF). We're cleaning up some of the loose ends in the specifications and we'll put it out to bid probably near the beginning of the year. We continue to track the capacity with the previous issues we've had the last couple of years with flows. I'm pleased to report that flows are down again for the month. We're showing the running average is about 85% of full capacity, when we were pushing close to 94%. I expect it will go down more because last November we were averaging 4.6 MGD and that was well over plant capacity and I don't think we're anywhere near that this year.

Mrs. Robitzski – Does it put us out of any kind of fine or monitoring? Mr. Madden – Yes, it keeps us well under the reporting percentage which is 95%, we were getting very close, so it takes some of the pressure off. We still need to go in and get rid of I & I. The metering; once you get those and you set them up, we'll hopefully find some low hanging fruit.

Mr. Tully – Where are you going to set up the meters?

Mr. Madden – We have a couple of ideas but we have to see where we are with the ACO because if we have to do the metering in the Flemington section first, we'd do that. If we don't have that ACO, we'd probably start around Dayton Road. Lastly, on the GIS, we've been working on creating a new database and we also met with your new CCTV camera truck vendor, trying to integrate their software with our GIS so everything meshes together.

Mr. Frank – Mr. Madden and I went to Readington and talked to representatives from there. They're looking to put in affordable housing and I told them we don't have any capacity to offer them. They were still going to try to shoe horn it in, by reducing their I & I to stay under their 125,000 gpd. Their flows have dropped significantly from wet weather to dry weather and they're thinking if they can get a handle on their I & I, they can squeeze in the 15,000 gpd that they are looking for.
